Federal Asset Management Compliance & Strategy Mandates – Reporting Impacts driving Enterprise Asset Management

EO 13800 - Strengthening the Cybersecurity of Federal Networks and Critical Infrastructure (2017)

- Objective: Drove 'Cloud First' Strategy
Enforces Cyber Security/FedRAMP
Expanded into 'Cloud Smart'
- Impact: Cloud based solutions, SaaS based, FedRAMP/ATO security compliance
Technology platforms to capture, maintain & sustain enterprise asset management systems
Drove IT Modernization and Digital Transformation initiatives

PMA Agenda - Data Accountability - Data Strategy and Infrastructure for the Future (2021)

- Objective: Enterprise Data Governance
Four Cross Cutting Drivers of Change → Policy, People, Process, Platform
- Impact: Leverages Data as a Strategic Asset
Enacted heightened data security measures, including CMMC Governance on CUI
EAM Data models impacted by data sensitivity measures & governance

Federal Asset Management Compliance & Strategy Mandates – Reporting Impacts driving Enterprise Asset Management

DOE Order – DOE O 430.IC - Real Property Asset Management (2016)

- Objective: Life-cycle management of real property management to utilize data-driven, risk-informed, performance-based approach to align with DOE Mission
 - Real property asset management planning & budgeting
 - Assess real property portfolio by core capability every five (5) years
 - Real Property Sustainment
 - Establish CMMS & Condition Assessment solutions for DM (deferred maintenance)
 - Establish 5-year forecast for sustainment for DOE real property assets
 - Condition Assessments for each asset for preventive or remedial activity every 5 yrs
 - Functional Assessments for each asset to meet DOE mission every 5 yrs
 - Performance Management
 - Establish Performance metrics to measure real property asset management performance
 - FIMS System for enterprise facility information to consolidate reporting
- Impact: DOE flow down accountability to all DOE offices and contracted Lab operations
 - Extensive actions across DOE facilities involving EAM/CMMS/BUILDER/IWMS platforms
 - DOE established extensive asset management criteria that applies to power grid entities and power coops
 - FCA & BUILDER engagements

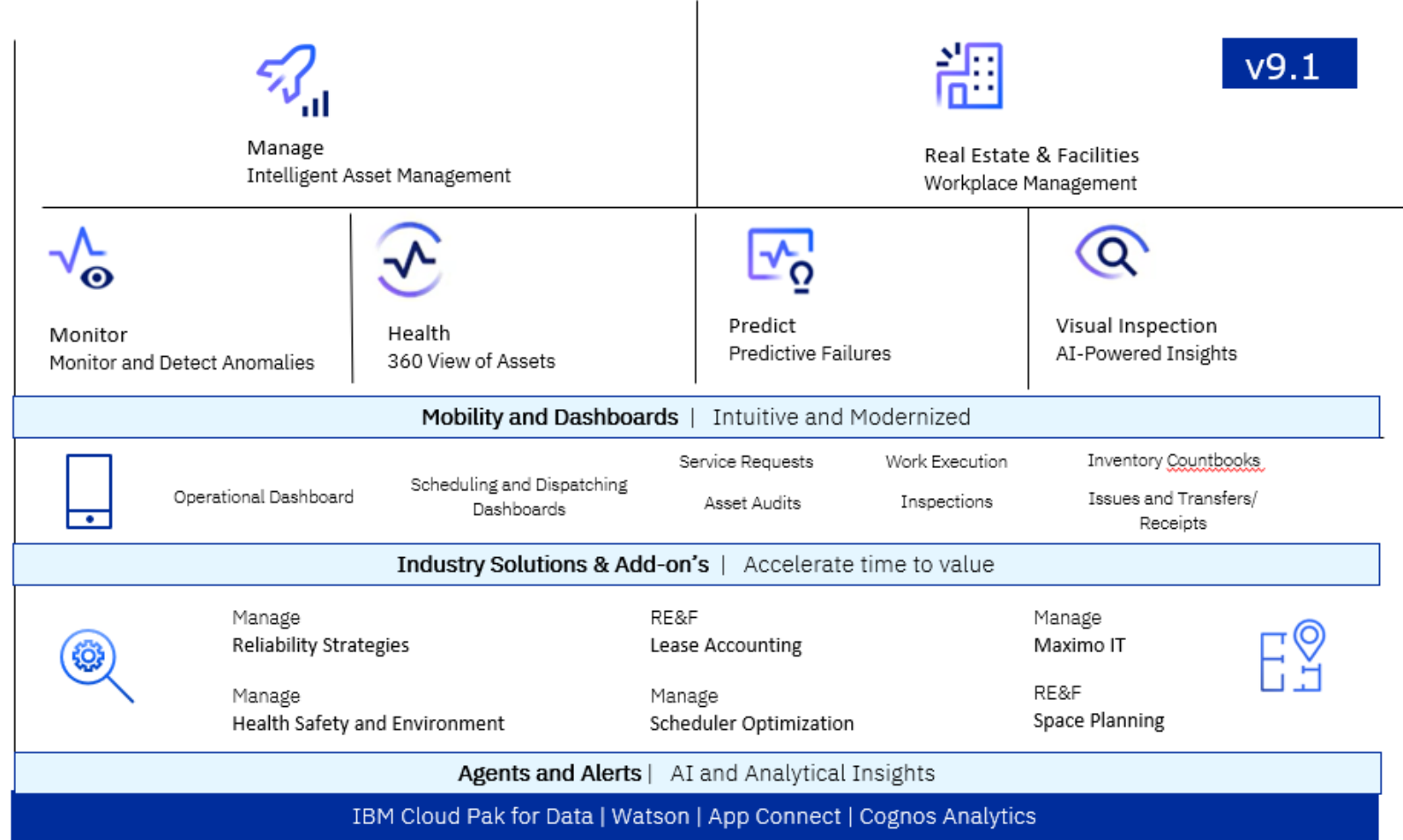

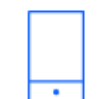

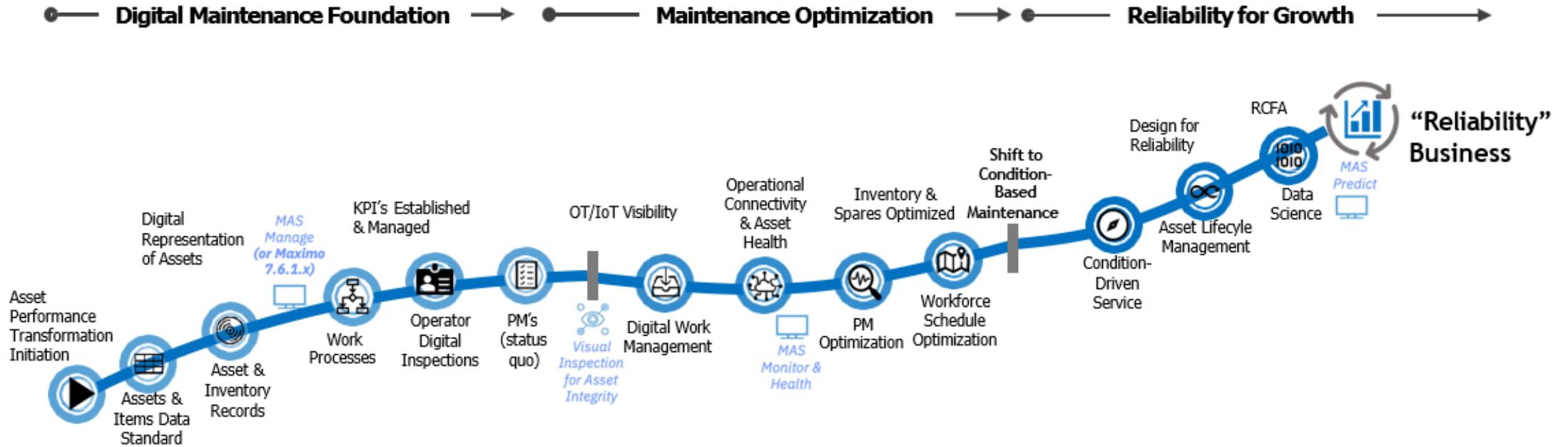

- Assets are at the foundation (ISO 14224)
- Consistent foundational principles – workflow lifecycle, asset classifications & criticality, essential care, and condition monitoring
- Equipment criticality established & scored
- Foundational failure modes & effects analysis (FMEA) mapped to assets

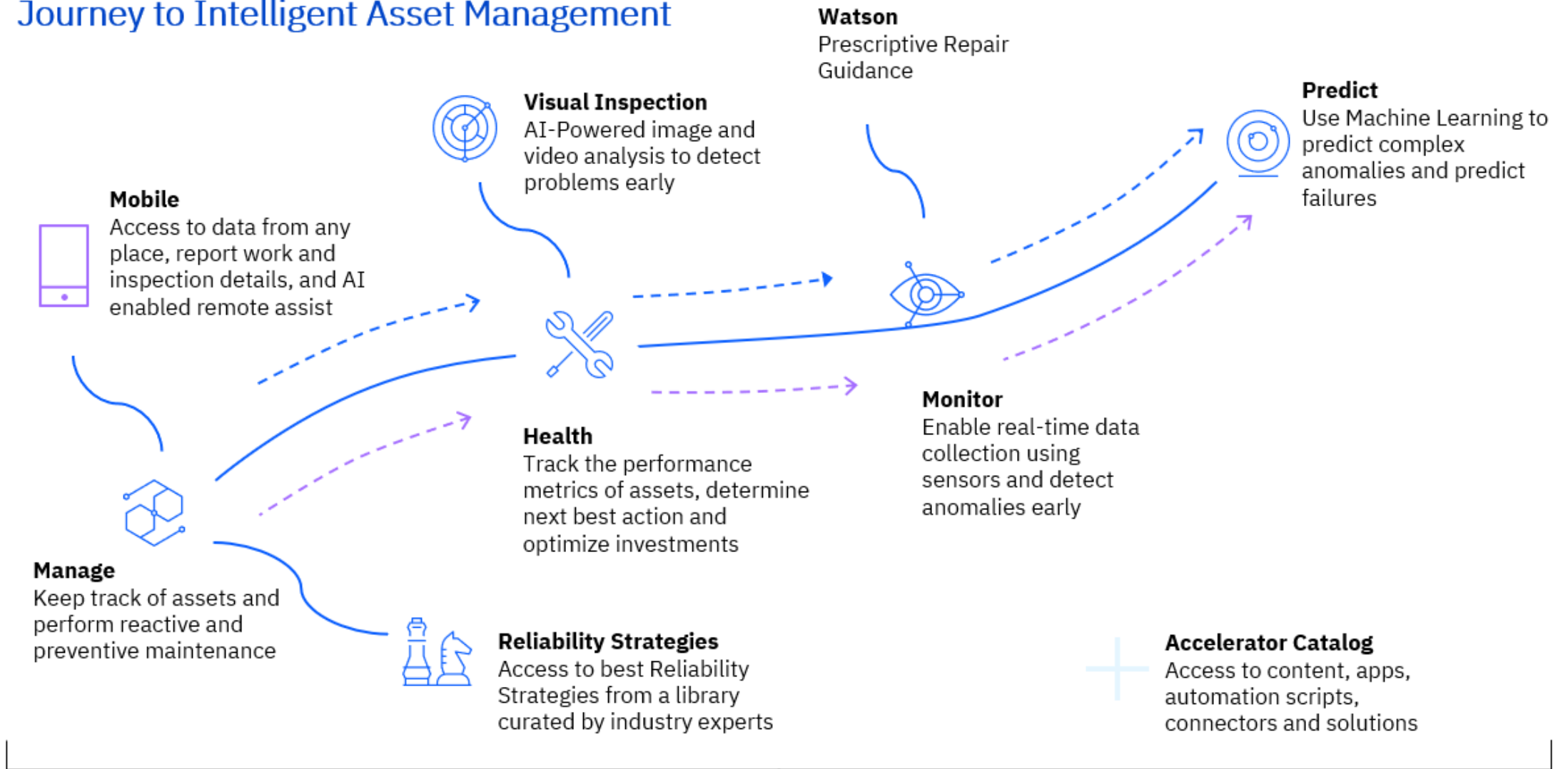
- Operational data integrated (OT + IoT)
- Multivariable objective asset health scoring
- Foundation for optimization – preventive maintenance (PM), workforce scheduling, inventory
- Directionally prescriptive work actions (augmented intelligence)

- Condition-driven approach to asset management
- Lifecycle asset management feedback mechanisms influence future asset design for reliability
- Failure modes & effects analyses (FMEA) governance
- Multivariate analytics & data science competency

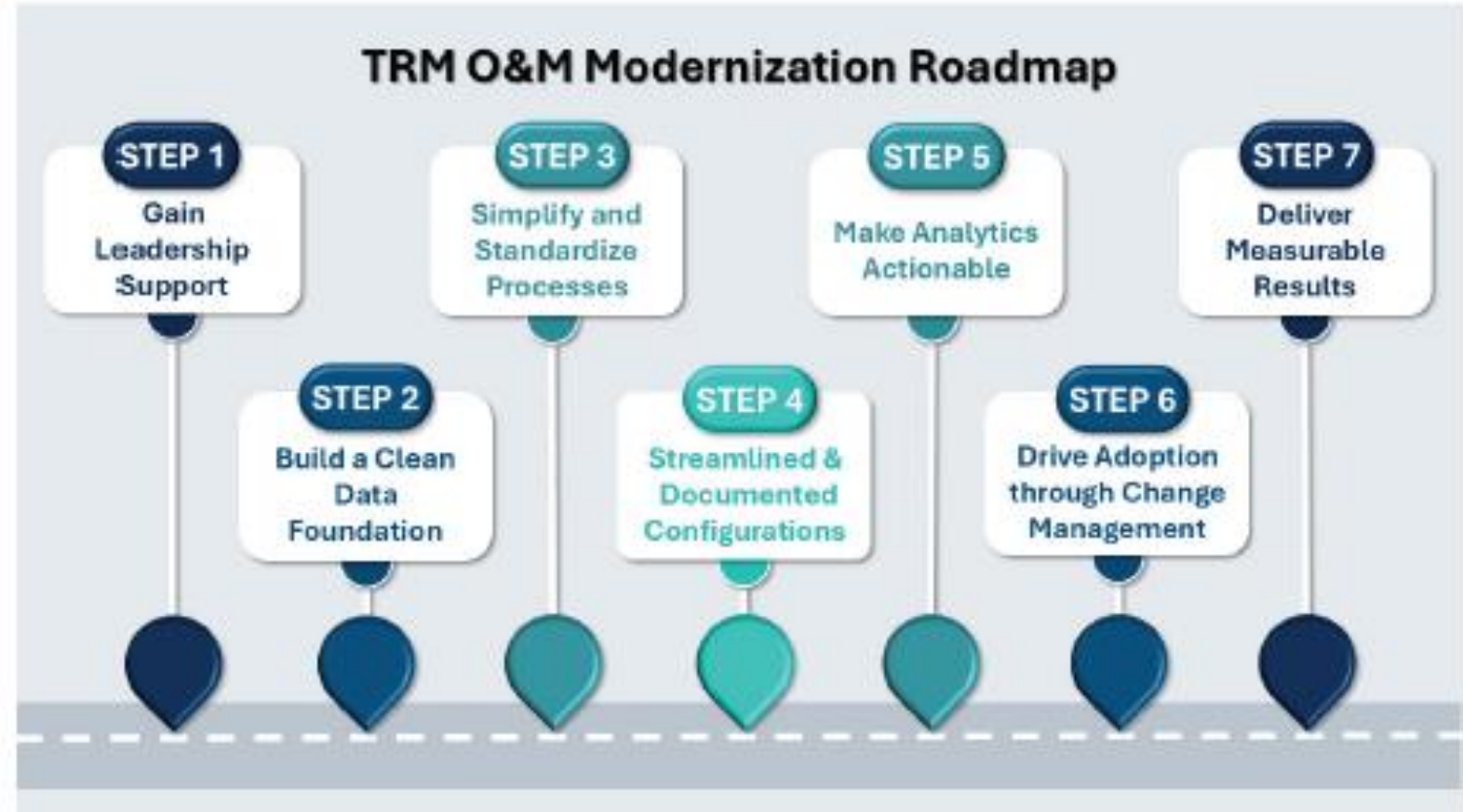

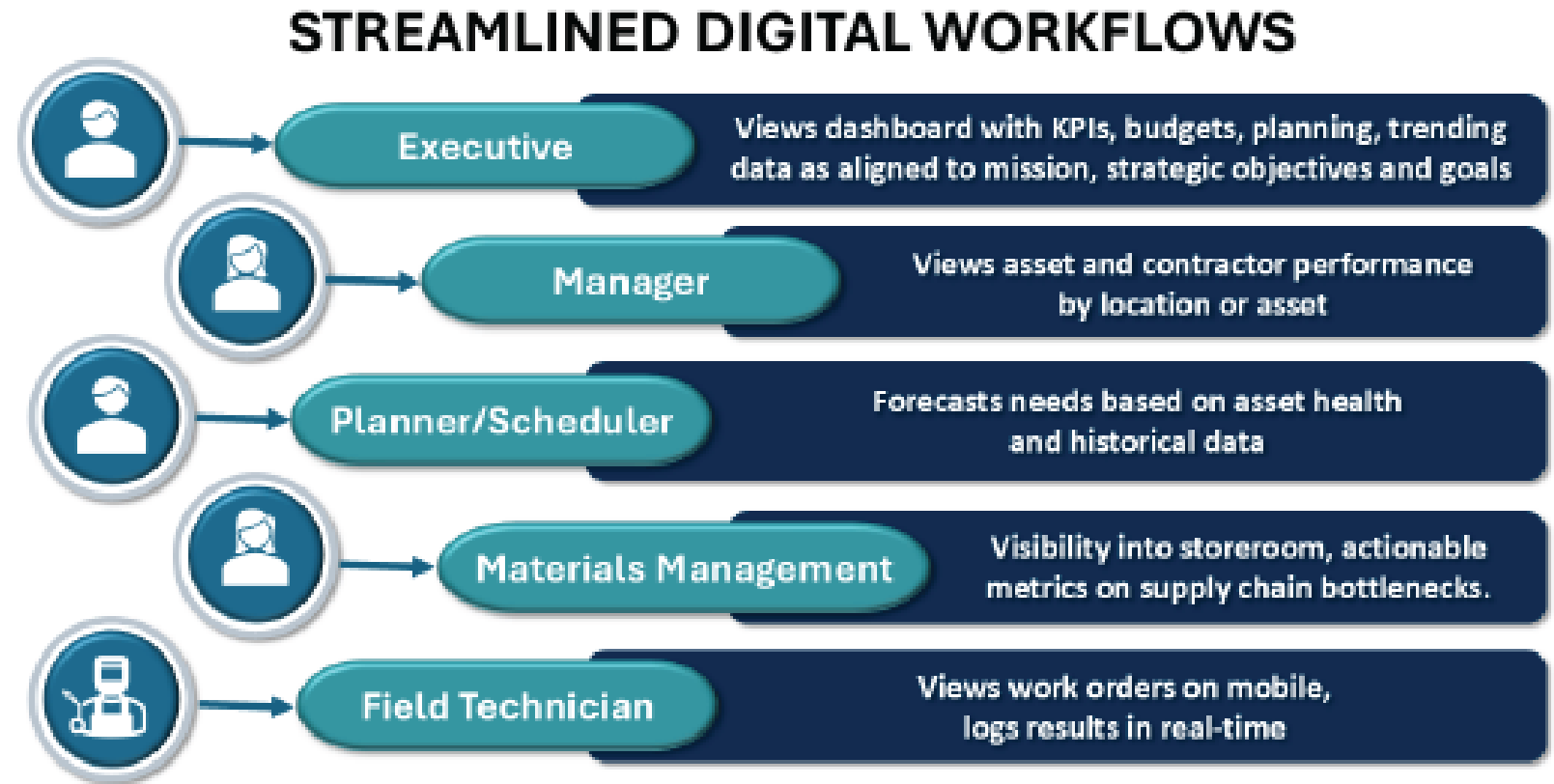

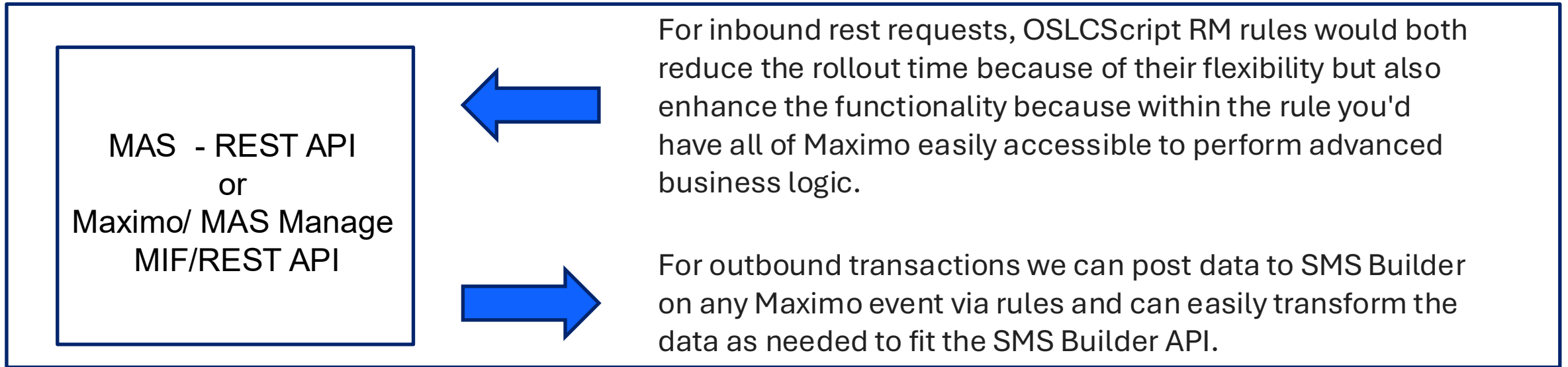
